## **CEMETERY AND FUNERAL BUREAU**

The following table summarizes the most common violations found during compliance inspections of <u>CREMATED REMAINS</u>. <u>DISPOSERS</u>. It is not a complete list of all violations for which the Bureau can take disciplinary action. The Bureau may issue a warning letter, an administrative citation or citation with fine, or may issue an administrative accusation for violations of the law.

The code sections below are contained in the California Code of Regulations (CCR) Sections 2300 – 2390, Business and Professions Code (BPC) Sections 119 and 7600 - 7746, and Health and Safety Code (HSC) Sections 7000 – 103800.
