From the CFB homepage, the consumer/licensee clicks on the Disciplinary Actions link. That link takes them to the Disciplinary Actions web page that provides a Disclaimer and Definition of Terms. At the bottom of the page there will be links, by year, linking to a table for that year listing the disciplinary information for the licensee/applicant. Clicking on the license number for the Licensee will take the consumer to the license verification page displaying licensee information and any links to public documents related to the licensee. The documents can also be accessed by searching under license verification.

Definition of Terms:

Accusation – An Accusation is a legal document formally charging a licensee with a violation(s) of the Cemetery Act or Funeral Directors and Embalmers Law, and notifying the public that a disciplinary action is pending.

Default Decision – A decision based on the licensee's failure to provide a Notice of Defense after an Accusation has been served, or failure to be present at an administrative hearing. All charges are deemed true, and the default decision normally results in a revocation of the licensee's license(s).

Effective Decision Date – The date the disciplinary decision/order goes into effect.

Proposed Decision – A decision rendered by an Administrative Law Judge through an Administrative Hearing which contains the determination of issues, findings of fact, and proposed order.

Revoked – The license is cancelled and the right to practice has ended.

Revoked, Stayed, Probation – The Bureau revoked the license, however, the revocation is "stayed" or temporarily set aside. The licensee may continue professional practice so long as the licensee complies with specified probationary terms and conditions. If the licensee violates probation, the Bureau may lift the "stay" and revoke the license.

Statement of Issues – A Statement of Issues is a legal document formally charging an applicant for licensure with a violation(s) of the Cemetery Act or Funeral Directors and Embalmers Law, and notifying the public that a disciplinary action is pending.

Stipulated Settlement – A licensee facing disciplinary action by the Bureau may negotiate a settlement or "stipulated agreement" prior to hearing.

Suspension – The licensee is prohibited from practicing for a specific period of time.

Voluntary Surrender – A licensee surrenders their license as a resolution to a disciplinary matter, subject to acceptance by the Bureau. The individual or business can no longer practice in the State of California.

Writ of Mandate – An appeal filed by the licensee in Superior Court asking the court to overturn the Bureau's decision.

Disclaimer for Disciplinary Action Summary

The reports contained as part of this web site represent summaries of those formal disciplinary orders issued by the Department of Consumer Affairs (DCA) and its participating programs, boards, committees, and commissions, imposing suspension, revocation or other discipline. Disciplinary proceedings which are resolved by dismissal of the accusation or otherwise result in no actual discipline of a license are not reported at this web site. The lack of a summary for a particular licensed person does not mean that the licensee has never been the subject of an accusation or administrative discipline.

Summary information on recent orders is prepared approximately ninety (90) days after the final decision date of a disciplinary case. Therefore, although this web site may presently lack any such report, some licensees will actually be named in accusations, or be subject to disciplinary orders.

The brief summaries offered at this web site are not intended as substitutes for the actual decisions and orders issued by the Department of Consumer Affairs. Copies of those decisions and orders are available at no cost by writing to the designated address for each program or board.

Also, the actions reported here may not be final and may not reflect any judicial action to stay or modify the administrative order. You should not take any action based on information contained in these summaries without verifying the information and determining whether the administrative order has been stayed or modified by a court.

As used in this summary, the term "accusation" is a formal document that notifies a licensee of the agency's charges against the licensee, and that requests a disciplinary order. The licensee is entitled to contest the charges in a formal hearing before an administrative law judge. An accusation is usually resolved by an agency decision following such a hearing or by an agency decision pursuant to a settlement agreement. Often there is a considerable period of time between the date of filing an accusation and the resolution of the accusation.
