OAL approved Section 100, “Change Without Regulatory Change,” on March 17, 2022.
  - c. Review of Proposed Language and Notices for [AB 293](#), (Kalra, Chapter 514, Statutes of 2021), Preneed funeral arrangements: unclaimed property. This bill has a delayed implementation date of January 1, 2023. The new law establishes procedures for when and how preneed funeral arrangements that are not claimed upon the beneficiary’s death should escheat to the state under the Unclaimed Property Law. It also requires a funeral establishment that intends to cease operations to provide notice to beneficiaries or trustors and

trustees of preneed funeral trusts, with certain requirements.
