Section 100 CHANGE WITHOUT REGULATORY EFFECT

Title 16, California Code of Regulations (CCR)

Subject Matter of Proposed Regulations: Schedule of Fees

Sections Affected: Title 16, Section 1257, of the CCR.

Pursuant to Title 1, Division 1, Chapter 1, Article 2, Section 100(a), of the California Code of Regulations (CCR), the Department of Consumer Affairs, Cemetery and Funeral Bureau (Bureau) submits this written statement explaining why the proposed repeal of Section 1257, Schedule of Fees, of Article 7, Division 12, of Title 16, of the CCR does not materially alter any requirement, right, responsibility, condition, prescription, or other regulatory element of any CCR provision.

Effective January 1, 2023, Senate Bill (SB) 1443 (Roth, Chapter 625, Statutes of 2022) enacted amendments to Business and Professions Code (BPC) section 7729 which fixes fees the Bureau has established in regulation at Title 16, section 1257. The Bureau proposes to repeal the entirety of section 1257 as SB 1443 fixes the exact amounts of fees prescribed by the regulation, as follows:

These changes are without regulatory effect because they make the Bureau's regulations consistent with a changed California statute (BPC section 7729) and (1) section 1257 is inconsistent with and superseded by the changed statute, and

Subject to the approval of the Office of Administrative Law, the Bureau proposes to repeal section 1257, Schedule of Fees, in its entirety.
